Family Office Exchange to Offer the Definitive Workshop on Starting a Family Office

"Family Office 101" to Help Families Get Off to a Good Start

Also included is a discussion of technology to support the family's reporting needs, office policies and procedures, and office budget and allocation of costs. Assessing the value of the office and developing the beginnings of governance that can evolve over time are the final critical elements of starting an office. Participants will hear from experts in each area, learn from current family office executives, and work in groups with their peers.

"By the end of the workshop," Ms. Neal says, "participants will have the tools to begin creating their own, custom roadmap for the next 18 to 24 months of their family office start-up."

"Family Office 101: Creating a Family Office Blueprint" is open only to wealth owners and family office executives. Membership in FOX is not required to participate.
